Creating an Account

Go to www.ApplyConnect.com and click the **Get Connected** button.

In order to register, you must provide:

1. Name
2. Email Address (used to login)
3. Current residency address
4. Date of Birth and Phone Number
5. Select Renter, Landlord or Agent
6. A password to login with.
 - 8 characters minimum length, and;
 - Any 3-combination of: Uppercase, lowercase letters, numbers, and symbols.
7. Pick from the available security questions and provide a secret answer.
8. Agree to the Terms and Conditions and click the **Register & Begin Ordering** button.

Confirming your Identity:

Now that you have created your account, you will need to verify your identity. On your dashboard click the **Confirm Your Identity** button.

- In order to verify your identity, you must confirm that the information provided at the registration page is correct.
- Click **Continue to Terms** then you will be asked to provide your social security number. Landlords and Agents have the option to not provide it, however if Experian cannot locate your credit profile, then a social will be required to proceed further.

If you have a credit monitoring service or have your credit frozen, it may not allow you to pull your credit profile.

Once Experian has located the credit profile, it will generate a series of 4 out of wallet questions based on the information on the profile. Once these questions have been answered correctly, you will be ready to start sending out invitations.

This is not running your credit report, it is simply generating questions to authenticate your identity.

Your applicant will receive an invitation in their email. In that invitation will be a unique link that directs them to create an account. They will be required to enter their name, address and social security number so that they can receive out of wallet questions to authenticate their identity. Once they have answered these questions, they will then have multiple ways to pay for this report such as Paypal, Visa or Master Card. Once payment has been made, a report will be generated. Once the applicant views the report, they are able to click “Share Report” and it will now be viewable on your Landlord/Agent dashboard.
